Your partner, NAME OF PARTNER, passed away on DATE. We would like to offer our condolences to you and the other surviving family members for this loss. Due to NAME OF PARTNER's passing, you may be entitled to a partner pension from StiPP. You have a lot to deal with during this time. We are happy to help you take care of the application as quickly as possible. This letter explains what we need before you can receive your partner pension.

Amount of pension capital

The accrued value of the pension capital is € AMOUNT. This amount will be distributed among all beneficiaries.

Your partner pension will be commuted

The partner pension you are entitled to is lower than the commutation threshold. This pension will be commuted. That means you will receive a lump sum instead of a (small) monthly pension payment. After this commutation, your entitlement to partner pension from StiPP will end. This letter indicates the gross commutation amount.

Commutation amount

If there are no children under the age of 18, you are entitled to a gross commutation amount of € AMOUNT. If there are any children under the age of 18, they may be entitled to orphan's pension. If this is the case, the gross commutation amount for the partner pension will be lower. We withhold the statutory deductions from this gross amount, excluding the payroll tax credit. The net amount will be transferred into the account number you have provided. After this commutation, you will no longer be entitled to partner pension from StiPP. For more details, see the explanation under 'Commutation of small pension' (*Afkoop klein pensioen*) at stippensioen.nl/afkoopinfo.

Note: The current pension capital may still change. This is due to employer corrections, for example. No rights can be derived from this statement.

Complete and send forms

Before we can pay out your partner pension, we need some information from you. We therefore ask that you complete and send the following forms within three months of the date of this letter:

- Application for children under age 18
- Account number specification

We have enclosed these forms with this letter. Once you have completed and signed the forms, you can scan them or take a photo of them and send them to us. You can do so using the contact form at stippensioen.nl/insturen.

Specification of your commuted pension

Shortly before you receive the commutation amount in your account, you will receive a specification of this amount. The specification will show the gross pension amount, the exact statutory deductions and the net amount you will receive.

Commutation may have consequences for allowances

The commuted pension falls under your income for the current year. This may have consequences for allowances (for example, healthcare allowance and housing allowance) or benefits. Please take this into account. More information about receiving your pension as a lump sum can be found here: stippensioen.nl/afkoopinfo. There are also instructions on how to request application of the special situations regulation by the Dutch Tax & Customs Administration. This will help you to protect your right to housing benefit (if applicable).
